

### Col Michael Farrell, USMC (Ret)

Colonel Mike Farrell is a graduate of Western



New England University with a degree in Business Administration. He later earned Master's degrees in Business from Boston University, in National Security and Strategic Studies from the Naval War College, and in

National Security Studies from the Army War College.

Following early assignments as a junior US Marine Officer, he became Commanding Officer of Marine Helicopter Squadron 262, Okinawa, Japan, a 200-person, 12 aircraft medium helicopter squadron.

Next, he was Executive Officer of Marine Aircraft Group 36. He was then selected to attend the Army War College. Upon graduation, he became Chief, Information and Intelligence Assessment Officer, United States Special Operations Command, in St. Petersburg, Florida.

From 2012-2015, he was Director of Operations supervising all Marine Corps operations in Europe and Africa, after which he became Chief of Staff, US Marine Corps Forces, South, then Chief of Staff, US Marine Forces Europe and Africa. Returning stateside he became Chief of Staff, US Marine Forces, Southern Command.

Upon his retirement he was a Senior Planning Analyst for Amyx, Inc, a defense combat support agency in Ft. Belvoir, VA. In 2020, he became the 34<sup>th</sup> Chief of Staff and Chief Operating Officer at the Military Order of the World Wars, Alexandria, VA.

### MG Gary Bunch, US Army (Ret)

Major General Harold Gary Bunch graduated from

Texas A&M University, College Station, TX, with a Bachelor of Science degree in Zoology. He also holds Master's Degrees from the U.S. Army War College, and U.S. Army Command and General Staff College.

# **Energy and National Defense**

#### ENVIRONMENTAL GREEN ENERGY COSTS By: LtCol Michael W. Menefee, USMCR (Ret)

The three most often talked about green energy alternatives are wind, solar, and electricity. While their benefits are frequently touted as carbon-free replacement sources of fossil-based fuels, few of their environmental impacts are discussed. When the total costs are calculated into the replacement costs and environmental damage they cause, they may not be as attractive as their proponents expect. In the haste to eliminate fossil fuels, the environmental concerns of these alternatives have often been ignored.

Windmills have a life span of 20-25 years, and the



span of 20-25 years, and the earliest windmills are already being decommissioned. In west Texas and other locales which were early adaptors of wind energy turbines, there is an increasing concern of the

environmental degradation the wind turbines cause when they are decommissioned. In Sweetwater, Texas there are over 4,000 of these blades piled up covering 25 acres. Each blade can weigh up to eight tons and can be longer than a Boeing 747 aircraft wing. Blades are made from a composite material composed of resins and fiberglass which are not recyclable. Several European countries are also turning to wind power. The United Kingdom already produces 100,000 tons per year of wind turbine blade waste. In most countries, blades are buried in landfills and will take centuries to degrade. Harvard estimates 720,000 tons of windmill blades waste will be dumped in US landfills over the next 20 years.

Solar panels have been advertised as a clean energy

alternative to provide electricity to homes and offices. They have a maximum expected lifespan of 25-30 years. By 2050, the International Renewable Energy



Agency estimates 78 million tons of solar panels in the US will have reached the end of their lifespan and will add six million tons of photovoltaic waste, each year. Solar panels contain toxic materials like lead and cadmium which contaminate the ground when they break down, and the costs of retrieving the silver and silicon from solar panels is greater than the costs of mining and producing it.

According to Japanese researchers, the value recovered from a lithium-ion battery used in EVs is also not worth the recycling cost. Only five percent of EV batteries are recycled, as it is five times less expensive to



mine new lithium than to recycle. Several rare earth metals are used in EV batteries lithium, cobalt, manganese, graphite, and nickel. Eighty

percent of these metals are found in China. Indonesia, Bolivia, Argentina, Chile, and Democratic Republic of Congo, have the next largest deposits. Future EV production targets may be threatened by the availability of these strategic metals. Mining these metals is very energy intensive and pollution is a factor. Small amounts of these metals are extremely poisonous to humans, and can enter our bodies through air, food, or water contamination. The battery life-cycle costs (mining, production, shipping, and waste) are often not figured into the environmental savings total.

Governments and green energy advocates should ad-

dress the facts that many of their green energy solutions will increase the global waste pollution crisis we already have. Our geopoliti-



cal environment could demand they seek alternative solutions rather than eliminating petroleum-based fossil fuels. This may be especially important if access to the needed rare earth minerals is restricted, and the waste pollution cost of their solutions to solving air quality is causing more environmental damage than the existing alternatives. Using an available, abundant, clean fossil fuel like natural gas may be a better energy choice until our technology and geopolitical situation improves.

# **Dallas Chapter MOWW**

## **Proposed Amendment #1**

**Purpose**: Patriot membership, a new membership category recently authorized by MOWW, must have certain criteria and guidelines included in the bylaws of a local chapter offering Patriot membership.

**Summary**: All changes regarding Patriot membership are in "Article III, Membership": (1) adding the Patriot category in Paragraph 3; and (2) Adding Paragraph 11 to enumerate the criteria and guidelines for Patriot membership.

All proposed changes to the Dallas Chapter Bylaws below are underlined and in bold.

# ARTICLE III

## Membership

- 1. Eligibility for membership in this Chapter shall be as provided by the National Constitution of the Order and as hereinafter specified.
- 2. Regular membership is open to citizens of the United States of America, of good moral character and good repute who have or are serving honorably as a commissioned officer or Chief Warrant Officer of the armed forces, the Public Health Service (PHS) or the National Oceanic and Atmospheric Administration (NOAA) of the United States and served on active duty between 6 April 1917 to present, or a citizen of the United States of America, of good moral character and repute who is an Officer's spouse or direct lineal descendent from such Officer.
- Classes of membership, as defined in the National Constitution of the Order, shall be (a) Regular, (b) Perpetual, (c) Senior, (d) Hereditary, (e) Memorial, <u>and (f) Patriot</u>. Honorary membership in the Order may not be conferred on any person.
- 4. Companions sponsoring a new member are responsible for verifying the eligibility and moral character of said potential new member. After signing a new member's application the sponsor will insure that it is forwarded to the Adjutant for processing.
- 5. All applicants are welcome to attend Chapter meetings pending action on the applications by National Headquarters.
- 6. A member may resign at any time prior to the expiration of their currently paid dues year and not be considered "Indebted to the Order".
- 7. Any member dismissed, cashiered, or dishonorable discharged from the armed forces, PHS, NOAA, or convicted of a felony offense by a court of competent jurisdiction, shall thereby cease to be a member.
- 8. Members may transfer to this Chapter from other Chapters of the Order upon receipt of evidence from the transferring Chapter that the member is in good standing.
- 9. Any member who is delinquent in the payment of their dues for six months shall thereupon be dropped from the rolls of the Chapter, provided that such member shall have been given ample notification of such delinquency at least two times, either by telephone or email, during delinquency period.
- 10. By majority vote of the Chapter Staff a former member may be reinstated by paying the full dues of the current year plus a reinstatement fee, as required by National Bylaws. The words "plurality", "majority", and "two-thirds vote" are based upon the number of Staff members present and voting.

# 11. <u>Patriot membership is designed to formalize and recognize those individuals who are not otherwise eligible for membership within the Order, yet through their support and contributions</u>

espouse and promote the values of the Order. The MOWW Patriot category is authorized at the chapter level and has no official standing within the larger National MOWW. This category will exist only at the discretion of, and will be managed by the local chapter.

**Guidelines for Patriot membership in the Dallas Chapter:** 

- A. <u>Individual shall not be eligible for Regular, Perpetual, Senior, Hereditary, or Me-</u> <u>morial membership.</u>
- B. Patriot member must be age 18 or older.
- C. <u>The MOWW Patriot will have no national, regional or chapter membership fees or</u> <u>financial obligation to the Order. The MOWW Patriot category and MOWW Pa-</u> <u>triots will incur no financial obligation from MOWW, Inc.</u>
- D. <u>An MOWW Patriot will adhere to the standards set forth for MOWW Companions.</u>
- E. An MOWW Patriot cannot vote at any level in the Order; Chapter, Region, National.
- F. An MOWW Patriot cannot hold an elected chapter, region, or national office; Commander, Vice Commander, Adjutant or Treasurer. An MOWW Patriot may not serve as a chair of any committee at all levels of the Order. An MOWW Patriot may not serve on the following chapter committees; Membership, Nominating, Bylaws. An MOWW Patriot is not authorized to speak on behalf of the chapter or the Order and cannot represent the chapter or the Order in any official capacity.
- G. <u>An MOWW Patriot can attend chapter, regional and national meetings, confer</u><u>ences, and conventions. An MOWW Patriot can serve on designated chapter com</u><u>mittees as determined by the Chapter Commander and may include committees</u> dealing with Law & Order, National Security, Homeland Security, Veterans Activities, and others designated ad hoc. An MOWW Patriot can be appointed to a position on a Chapter Commander's staff to include Historian, Judge Advocate, Surgeon, Chaplain and Newsletter Editor. An MOWW Patriot will wear a name tag designating the wearer as an MOWW Patriot when attending MOWW functions.
- H. Entrance of an MOWW Patriot within the chapter may be recognized by a certificate for the MOWW Patriot but will not include an official pledge to uphold the Order's Constitution and Bylaws.
- I. <u>Nomination of a prospective Patriot candidate can be made by any chapter member in good standing by submitting the name and contact information of both the candidate and the nominating member to the chapter adjutant. Ideally the nomination will have a brief (90 words or less) summary of support and contributions to the chapter. A majority vote by the chapter staff will forward the nomination to the membership to be decided by a majority vote at a regular membership meeting.</u>

# **Proposed Amendment # 2**

**Purpose**: When a staff position is vacated, or when there is no candidate for a position at the annual election, such staff vacancies can be temporarily filled until the next election the following May.

**Summary**: All of the changes for this proposed amendment are under "Article V, Election of Officers", by adding Paragraph 6.

All proposed changes to the Dallas Chapter Bylaws below are **underlined and in bold**.

# ARTICLE V

## Election of Officers

- 1. At the regular monthly meeting in March of each year, the Commander shall appoint a Nominating Committee that shall be chaired by the immediate Past Commander and shall be staffed in accordance with Article VIII, paragraph 1. At the regular Chapter meeting in April the Nominating Committee shall report to the Chapter, making nominations for the several elected offices in the Chapter. Other nominations may be made by members from the floor following the report of the Nominating Committee.
- 2. Chapter officers shall be elected at the regular Chapter meeting in May of each year. A plurality of one vote shall elect any officer. The Commander, as presiding officer, does not vote, but votes only to break a tie.
- 3. Chapter officers as elected shall be formally installed, with proper ceremony, at the annual installation meeting in June of each year and shall hold office for one year or until their respective successors are elected and qualified.
- 4. Any elected officer who shall neglect or fail to perform properly the duties of their office may be removed by a two-thirds vote of the Chapter Staff at any regular meeting of said Staff.
- 5. All officers shall service without compensation.
- 6. <u>Vacancies of these elected officer positions may be filled by a majority vote of the staff at a staff meeting at which a quorum is present and the intention to vote on the vacancy has been announced to the staff at least 10 days in advance of the vote. A staff member elected to fill a vacancy under this paragraph shall be elected for the unexpired term of the applicable vacant office the term to automatically end at the next May chapter meeting and not to exceed 364 days. This procedure for filling vacancies of elected officer positions shall not be used to bypass the election of officers set out in Article V, Election of Officers, Paragraphs 1 through 5 of these Bylaws. Vacancy of an elected officer position occurs when an officer, duly elected in the annual election vacates that office, or when there was no candidate for the elected office at the time of the annual election.</u>

# Proposed Amendment # 3

**Purpose**: In attempting to form the nominating committee, the most recent past commanders may be unwilling or unable to serve. This proposed amendment allows going farther back to additional past commanders to form the nominating committee.

### Summary:

- 1. Article V, Paragraph 1. Election of Officers has some words deleted because they disagree with Article VIII, paragraph 1.
- 2. Article VIII, paragraph 1, Committees, Nominating has words added to clarify that the four most recent available past commanders can serve.

# ARTICLE V

## Election of Officers

7. At the regular monthly meeting in March of each year, the Commander shall appoint a Nominating Committee that shall be <u>chaired by the immediate Past Commander and shall be</u> staffed in accordance with Article VIII, paragraph 1. At the regular Chapter meeting in April the Nominating Committee shall report to the Chapter, making nominations for the several elected offices in the Chapter. Other nominations may be made by members from the floor following the report of the Nominating Committee.

# ARTICLE VIII

### **Committees**

1. Nominating

The Nominating Committee shall consist of the four most recent **available** living Past Chapter Commanders, of whom the most recent shall be the Chairperson. The Nominating Committee shall be appointed by the Commander in March and shall report on its nominations for officers at the regular Chapter meeting in April. Note: A Past Chapter Commander is not considered available if that Past Chapter Commander has moved out of the Dallas area, has declined serving, is incapacitated, or has not responded to a request to serve after a reasonable effort to get the Past Commander's response.
