## This Month's Program: Law Enforcement

### VALOR in North Texas Veterans Courts

Judge John Roach, Jr. has been the presiding judge of the 296th District Court in Collin County, TX since 2006. The 296th District Court hears felony criminal, civil, family law and Child Protective Service cases and is recorded as being the busiest court in Collin County for the last 10 years.

Judge Roach presides over the Nation's very first region-wide **Veterans Court** initiative, which has become the model for Veterans Courts across the Nation.

A Marine Corps Veteran, Judge Roach served as a Fire and Rescue Specialist in the United States Marine Corps Reserves and served on active duty in support of Operations *Desert Shield & Desert Storm* in the 1990's.

After launching the Collin County Veterans Court in 2013, Judge Roach quickly recognized the need to reach into smaller, more rural North Texas counties that could not support a Veterans Court on their own. His initiative and dedication to service has led to the partnership of five North Texas counties – Collin, Rockwall, Grayson, Kaufman, and Fannin – who now serve as One.

It was his initiative to service that has led to the creation of the **VALOR** Program, (**V**eterans' **A**ccess to **L**ifelong **O**pportunities for **R**ehabilitation).

## The Commander's Corner

### Sheep, Wolves, and Sheepdogs

In his book, *On Combat*, U.S. Army LTC Dave Grossman, recounts an assessment of human nature and society. He noted that most of the people in our society are sheep. They are gentle, passive, productive creatures who only wish to be left alone.



The word "sheep" is not meant as a pejorative. It just refers to the basically nice people who cannot or will not stand up for themselves or for others, either because they are embarrassed, emotionally overwhelmed, or ignorant about how to behave in an intimidating situation.

Then there are the wolves, who skulk among us looking for easy prey. Wolves are the *evil* in every society. They prey on the meek. Few of them are brave enough to engage an equally armed opponent in the open light of day. Wolves prefer to riot, kill, and destroy.

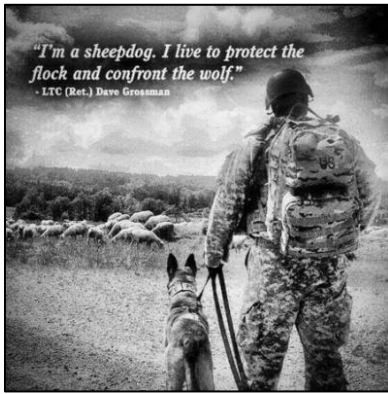
Throughout history there are some that are neither sheep, nor wolves. They are the Sheepdogs.

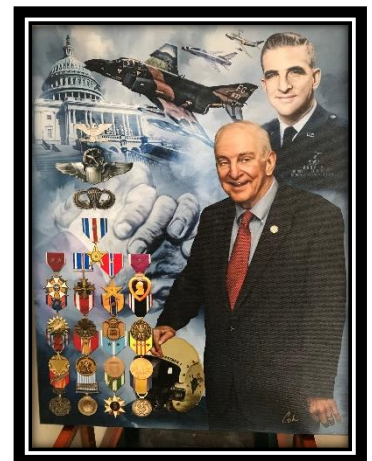

# KNOW YOUR INCOMING OFFICERS

## Captain Richard Stewart, US Navy (JAG)

Captain Richard Stewart was born in New Orleans, LA



and received his BA degree from Dillard University, Juris Doctorate from Loyola University (New Orleans) School of Law,; and a Master of Laws degree from The George Washington University School of Law, Washington, DC.

During the Vietnam War, he served as a line officer on board the *USS New Orleans* (LPH 11). As Commanding Officer, Naval Legal Service Office, Corpus Christi, TX, Captain Stewart received the National NAACP Roy Wilkins Renown Service Award. During Operation Desert Storm, he was presented a citation by the Secretary of the Navy. While serving as Command Judge Advocate, Naval Station Alameda, CA, he was recognized by the U.S. Attorney. His military decorations include the Legion of Merit, Navy Meritorious Service Medal, Navy Commendation Medal, and the Vietnam Service Medal.

In 1994, following a distinguished career in the Navy Judge Advocate General's Corps, he joined the Verizon Legal Department. He retired as Assistant General Counsel, Verizon Communications, in 2013.

Richard is Chair of the Appraisal Review Board of Dallas County and served as Chair of the City of Irving Arts Board from 2013 – 2015, Vice Chair of the Las Colinas Medical Center Board of Trustees, Irving, Texas, and, he is a member of the University of North Texas, College Of Law, in Dallas.

Mr. Stewart is admitted to practice before the Supreme Court of the United States; US Fifth Circuit Court of Appeals; Supreme Courts of Texas, Louisiana, and the District of Columbia; as well as the US Court of Appeals of the Armed Services, to name a few.

Richard is married to Sandra [King] Stewart, a vocalist whose recordings include “*Leave it up to the Boys*” on the *Night Train to Nashville*, CD.

The Stewarts' son, James, is a graduate of Howard University, and daughter, Tanesha, is a graduate of Spellman College and George Washington University. The Stewarts are members of St. Paul UMC, Dallas, Texas.

## Major Bill Coleman, US Army (Treasurer)

Bill Coleman was born in Los Angeles in 1948 while



his father, Jack Coleman, a WWII Army veteran, attended the Univ. of Southern California on the GI Bill. Bill attended college at NMSU in Las Cruces, NM, during which he participated in a program tracking navigation satellites for the US Navy. He traveled to the Philippines, Suriname, Curacao,

and Argentina using mobile tracking stations to provide GPS location information to Polaris submarines and ships at sea. Bill then enlisted in the U.S. Army and was accepted into Field Artillery (FA) Officer Candidate School at Ft. Sill, OK. He was the Honor Graduate of his class.

While on active duty, he served as a nuclear warhead assembly team officer, in the 28<sup>th</sup> FA Detachment in Italy, where he met his future wife, Mirella, and was later awarded an Army Commendation Medal.

Bill left active duty, returned to college, and received both a Bachelor of Arts and a Master of Fine Arts in Cinema, from the University of Southern California. He resumed his military career as a member of the California Army National Guard, serving as a platoon leader in a 155mm Self Propelled Artillery unit.

When Bill and Mirella returned to Texas in 1977, he put his film degree to use and secured a position in Public Affairs at the Texas NG headquarters, in Austin. Bill served the next 15 years as a Public Affairs Officer, first in the 100<sup>th</sup> PA Detachment in Austin, and then as PAO for the 49<sup>th</sup> Armored Division. He received a commendation from the National Guard Bureau for his handling of 2 fatal training accidents at Ft. Hood.

At the direction of the Division Commander, Bill published the first yearbook for the 49<sup>th</sup> AD in over 20 years, for which he received his second Army Commendation Medal.

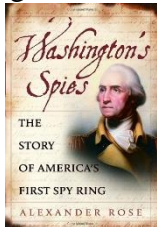
In civilian life Bill is an independent life insurance agent. He has served for 6 years as the president and 16 years as a board member for the Ferguson Road Initiative, a non-profit representing over 40,000 residents of east Dallas.

## The National Intelligence Community

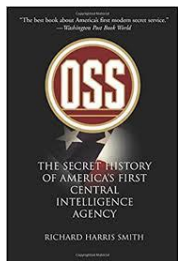
Intelligence has been called the second oldest profession. In the Bible, Numbers 13 describes one of the first recorded intelligence collection events in history when Moses directed Joshua to lead spies into the promised land.

In the Revolutionary War, General Washington created the Culper Spy Ring (1778-1783) in and around New York to help defeat the British. Intelligence was collected during all wars after the American revolution, but these units were mostly tactical and demobilized after each war.



In the Civil War, the first photo imagery intelligence was used by union forces in observation balloons. The Office of National Intelligence was founded in 1882, as the first permanent US intelligence agency, followed in 1885 by the Military Intelligence Division. The predecessor of the FBI was established in 1908.

In World War II, the Office of Strategic Services (OSS) became the forerunner of today's CIA and State Department's INR. After the Bay of Pigs invasion failure in 1962, DIA was created to consolidate military intelligence from the services.



As the US threats evolve, more capabilities are needed to defend our country.

After the intelligence failures of 11 Sep 2001, the Office of the Director of National Intelligence (ODNI) and the Department of Homeland Security (DHS) were formed.

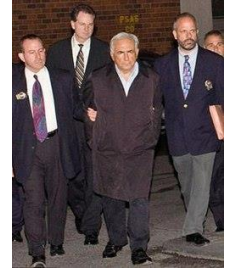
Each person authorized to have access to classified intelligence must undergo a background check to obtain a security clearance. Today, there are three US intelligence classifications: Confidential, Secret, and Top Secret.



The level of clearance one needs determines the level of investigation. All military officers are required to have at least a *Secret* level clearance, as are enlisted military personnel working with a broad range of our weapons systems, classified projects, or duties which require them to have access to sensitive information.

Many government officials, defense contractors, and university researchers working on government projects must also have clearances. The level of security clearance is job dependent.

Most elected officials receive clearances by virtue of the nature of their official duties. Not everyone applying for a clearance is able to pass the background checks. Despite the perception that some officials seem to be above the law, it is still a **felony** to mishandle or leak classified intelligence. Violators can and should be held accountable for revealing the nation's secrets.



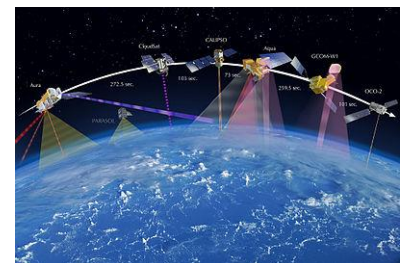
Even senior cabinet level Secretaries, advisors, college professors, defense contractors, and DCI's have mishandled classified intelligence. In most cases, harsher penalties have been given to intelligence personnel, military, or government civilians who mishandle classified information. In the military, even minor disclosures of classified information can lead to severe punishment.

Most Americans have no "need to know" classified information. Especially when knowledge of the methods and sources used to obtain the intelligence can subject those sources to compromise, capture, torture, or death.

Within the Intelligence Community personnel who have Top Secret clearances, may still be denied access to certain data, due to "compartmentalization". Again, the criteria for access is based on a "need to know".

Only the highest government officials, IC personnel, and military officers have access to extremely sensitive information, and the ODNI, by law, has more information than any other American.

Most Americans will never know the threats eliminated, actions not taken, and attempts to undermine our country's policies and values, which are prevented by our global Intelligence Community.

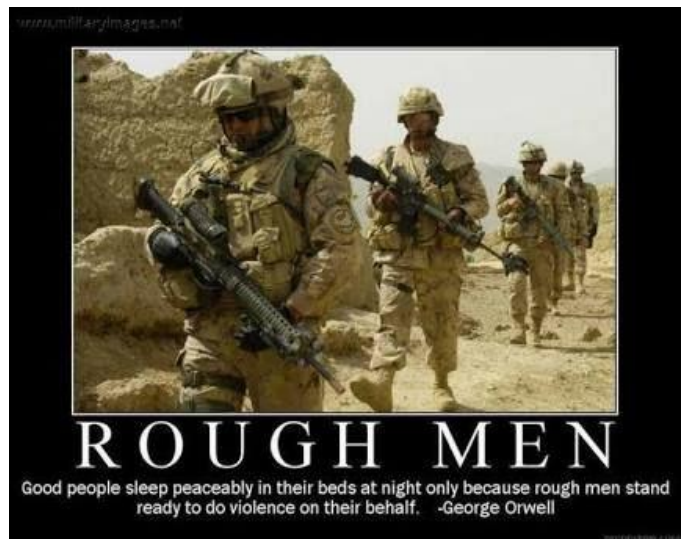

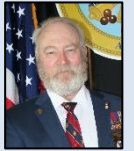
