


Commander's Report

RUSSIA COLLUSION HOAX AND THE INTELLIGENCE COMMUNITY

At the end of July 2025, the Director of National Intelligence (DNI) Tulsi Gabbard and DCI John Ratcliffe released documents providing a direct whistleblower account from the Intelligence Community (IC) exposing serious issues involving the manufacturing and manipulation of false intelligence. The documents exposed the activities of former DNI James Clapper and former CIA Director John Brennan. It also mentioned a supervisor who tried to pressure the whistleblower to endorse key findings from an Intelligence Community Assessment (ICA) requested by former President Barack Obama. The altered 2017 ICA falsely assessed that the Russian government supported Candidate Donald Trump over Candidate Hillary Clinton, and the Russians interfered with the 2016 presidential election. President Obama knew the 2017 ICA and the Steele dossier contained false information. Former 2016 presidential candidate, Secretary Clinton, was so distraught over losing the election to Candidate Trump, that she serially repeated in multiple interviews and speaking events that Russia had interfered in the US election, knowing this Russian interference allegation was false. Although Russia has historically tried to influence US elections and other democratic elections in the West, using social media, disinformation, hacking, and stolen information, Secretary Clinton and her team could not believe her rejection by the American electorate and electing President Trump.


Recently released classified documents prove the Russians favored Secretary Clinton but were trying to undermine the confidence of the American voters, not trying to swing the election in either political party's favor. These classified documents further show the Russians were unsuccessful in undermining the confidence in the US voting system and did not hack the 2016 election. In December, after the election, DNI Clapper pulled the ICA that refuted the Russia Hoax. Within days after the ICA was pulled, President Obama met with DNI Clapper, FBI Director Comey, DCI Brennan and other officials to plan a new ICA on "Russia election meddling." On 9 December, newly released documents show DNI Clapper's executive assistant emailed IC leaders to create a new ICA requested by President Obama to discuss the actions and tools the Russians used in the 2016 election. Obama administration officials used their media contacts to plant false stories in The Washington Post and The New York Times outlining the false Russia Collusion story including the now debunked Steele dossier, which was later found to be a Clinton campaign political dirty trick which was proven to be false also. The old media news outlets covered these imaginary revelations as if they were factual. Both The Washington Post and The New York Times won Pulitzer Prizes for their fictional coverage, which they have not yet returned.

This altered intelligence caused many of Trump's senior officials to declare bankruptcy and almost destroyed the first term of his presidency. Criminal and unethical behavior by senior intelligence officers and government leaders cannot be tolerated. FBI Director Comey has now been criminally indicted, and formal criminal investigations have been opened against former DNI Clapper and DCI Brennan. Others may face criminal charges for trying to undermine and destroy a newly elected president and cause great harm to the country. Modifying the 2016 ICA to fit their false political narrative, gave deceitful credence to a fictitious story about the incoming Trump administration and further divided an already fractured public. Intelligence officers responsible for altering and weaponizing intelligence, to bias the public to believe in the phony Russian Collusion Hoax and Steele dossier, should be prosecuted.
